#### **Old Business:**

- 1. The Goodhue County Comprehensive Plan Survey was reviewed and completed for review by the Town Board.
- 2. The First draft map for recommended re-zones in Sections 15, 16, 17 and 18 was reviewed and found to be accurate to the Planning Commission's minutes and the technical assistance provided by Goodhue County GIS. It was noted that the eastern part of the map was outdated; Goodhue County Zoning had indicated that it might take a few attempts to get everything correct on the map.
- 3. The Charts For setbacks by zone, was reviewed for size and accuracy; either chart would be acceptable for Town Board review. On comparison, the smaller font 9 print seemed to be less readable.
- 4. Some previously reviewed housekeeping items were slated for a likely "line by line" review beginning in July with a comparison of the county language and the township language regarding multiple roadway intersections and the setback controls imposed.
